Introduction

The report of actions is fundamental to quality assurance for the Athens University of Economics and Business (AUEB), as it combines evaluation, transparency, feedback and strategic development. Through this process, the Quality Assurance Unit of AUEB achieves continuous improvement, enhancing the reputation of the University, responding as effectively as possible to the requirements of stakeholders.
