### **REQUIRED DOCUMENTS:**

- 1. University Degree with official transcript or Certificate of completion of studies with official transcript (if not in English or Greek, a certified copy of English translation is also required).
- 2. Certificate of strong command of the English language (Level C1 or C2) (e.g. TOEFL with a grade greater than 79, IELTS with a grade greater than 7, TOEIC with a grade greater than 785, etc). Applicants who don't own the certificate when applying, must submit a solemn declaration of article 8 of Greek Law 1599/1986 declaring that, in case they are accepted to the Program, they must submit the certificate in due course.
- 3. Two academic recommendation letters. They must be sent directly by the referees (academic staff) to the Program's Secretariat electronically (either by email or uploaded to the online applications portal).
