CALL FOR APPLICATIONS - INTAKE SEPTEMBER 2025

The Program is accredited by the Association of MBAs (AMBA) since 2005 and is offered exclusively in English. A rich, constantly evolving academic program allows students to customize the curriculum to fit their personal and professional needs and interests, while a wide array of extracurricular activities help them adopt an international perspective, strengthen their interpersonal, managerial and leadership skills, and cultivate their entrepreneurial capabilities. The program attracts students from more than 20 countries and for many years occupies top positions in international rankings. Committed to stimulate extroversion and innovation, the MBA International's mission is to educate visionary, confident and respectful leaders through a transformational learning experience of highest international standard that bridges academia, business and society.

The Program operates in accordance with the Regulation of Postgraduate Program (Bulletin B' of the Greek Government Gazette No. 6041/19.10.2023) and Law 4957/2022.

The MBA International offers a Full-Time Program of 3 semesters and a Part-Time Program of 5 semesters.

The Program has a rolling admissions procedure, conducted in three rounds:

- 1st round, 10th of January till 3rd of March 2025,
- 2nd round, 4th of March till 28 April 2025,
- 3rd round, 29th of April till 9th of June 2025.

Admissions are subject to both an upper and lower limit of students, based on accreditation criteria and the regulations of postgraduate programs.

Criteria and Selection Procedure

Applications are submitted electronically through: https://e-graduate.applications.aueb.gr/?lang=en_US

- Register and login to the link above.
- Find the **MBA International (Διοικητική των Επιχειρήσεων με Διεθνή Προσανατολισμό)** through the list of the available Postgraduate Programs in the Department of Management Science & Technology, School of Business.
- Select the Full-Time or Part-Time Program.
- Select and complete the form in English language. Make sure to double check that the English language form is used.
- **In the field of Greek requested data, proceed with completion in Greek language and characters not with Latin characters.**
- Complete all required fields in the application form. If any personal data is not applicable please type “-“.



Notice:

- You should complete the online application and click “Submit”.
- You should compulsorily complete the contact details for the recommendation letters in the respective fields. No recommendation letter will be acceptable in any different way.
- **None of the other required supporting documents** (CV, Degrees, Transcripts, etc.) **needs to be uploaded to the system.**
- After submitting the online form, applicants must send by post or submit in person to the Secretariat’s office the **signed** printed form of the electronic application along with the required supporting documents within the **next five working days** following the online submission.
- Copy of the proof of English language proficiency (see further point 5 below) must be certified.

Documents that Must be Submitted:

1. Completed Application form (printed and **signed**).
2. CV in English.
3. Copies of all University Degrees/Diplomas. For non-Greek degrees a recognition by the Hellenic National Academic Recognition Information Centre –DOATAP- is required. The applicant should check if their University is included in the [National Registry of Foreign Recognized Higher Education Index](#). Otherwise, the applicant must contact the Secretariat.
4. Official Academic Transcripts of the above copies of Degrees. (In case the transcripts are not in English or Greek, a certified copy of English translation is needed).
5. The original certified, by the issuing authority or by a lawyer, English language degree. {Cambridge or Michigan Proficiency/TOEFL/IELTS, or any other certificate of English language at **C2 level**, as defined by the ASEP ([ΦΕΚ 594/Β/7-2-2023](#))}.
Candidates from the People's Republic of China can submit the CET certificate «College English Test» (CET-4 & CET-6)
6. Copies of degrees of other foreign languages (optional).
7. Proof of full employment record. Admission requires a minimum of three years of working experience for the Full-Time program and five years of working experience for the Part-Time program.
8. Two **confidential** recommendation letters that must be submitted by their authors after receiving an automatic notification in their email following the submission of the online application.
9. Military Discharge Papers (if applicable).
10. GMAT (**optional** only, for score above 550).
